The Boy Scouts of America Council Alumnus of the Year Award is the Scouting Alumni & Friends' highest recognition. The award was established to recognize alumni of the Boy Scouts of America (BSA) who, over a sustained period of time, have used the skills and values they learned through their association with Scouting to make significant and long-lasting contributions to our nation through their careers, avocations, community service, and the Boys Scout alumni program and alumni activity at a council level.

A BSA alumnus includes anyone positively and personally impacted by the BSA – former Scouts, family members of Scouts past and present, community leaders and the millions of Americans who benefit from Scouting in their communities every day.

PHILOSOPHY

The future of any organization is embodied in the value of its program and the contributions of its alumni over time. The acorn was selected to represent the BSA Council Alumnus of the Year for many reasons including:

- Mighty oaks from little acorns grow
- Scouts and Scouters plant seeds for trees under which they may never sit

Evaluation will be based on the following criteria:

- Demonstrated advancement of Scouting alumni activities at the council level. (Maximum consideration = 80%)
 - Includes actives, leadership, and specific accomplishments or impact on behalf of Scouting alumni.
- Contributed significantly through community service to Scouting or other organizations. (Maximum consideration = 10%)
- High honor or distinction in career or avocation. (Maximum consideration = 10%)

In weighing the three requirements, significant important will be given to alumni activity.

Nomination and Selection Process

Nominations must be submitted to Scouting Alumni & Friends. Submission may be scanned and sent electronically to BSAalumni@scouting.org Mailed submissions may be sent to P O Box 152079, Irving, TX 75015. Mailed submissions to the local council office must be postmarked by December 31. The honoree will be presented at a meeting, venue and time of the local council's choice.

To prevent embarrassment, the candidate should not be notified of the nomination. The local council alumni committee will review the nomination and determine whether and to whom an award will be presented. Self-nomination is prohibited. A maximum of one recipient will be honored per calendar year.

Award Presentation and Recognition

The honoree will be provided with suitable recognition including a plaque, certificate, lapel pin, medallion and device to affix to the alumni award.
