Additional information

Nominators may attach supporting documentation as deemed necessary. (Supporting documentation may include news articles, resume or biography, references to candidate on the Internet, Scouting and other awards received, educational preparation, description of nominee's responsibilities over time, published works, etc.) This award is not a person-of-the-year, general lifetime achievement, or a different version of the Silver Beaver Award.

Evaluation will be based on the following criteria:

- Demonstrated advancement of Scouting alumni activities at the council level. (Maximum consideration = 80%)
 - o Includes actives, leadership, and specific accomplishments or impact on behalf of Scouting alumni.
- Contributed significantly through community service to Scouting or other organizations. (Maximum consideration = 10%)
- High honor or distinction in career or avocation. (Maximum consideration = 10%)

In weighing the three requirements, significant important will be given to alumni activity.

Nomination and Selection Process

Nominations must be submitted to Scouting Alumni & Friends. Submission may be scanned and sent electronically to BSAalumni@scouting.org Mailed submissions may be sent to P O Box 152079, Irving, TX 75015. Mailed submissions to the local council office must be postmarked by December 31. The honoree will be presented at a meeting, venue and time of the local council's choice.

To prevent embarrassment, the candidate should not be notified of the nomination. The local council alumni committee will review the nomination and determine whether and to whom an award will be presented. Self-nomination is prohibited. A maximum of one recipient will be honored per calendar year.

Award Presentation and Recognition

The honoree will be provided with suitable recognition including a plaque, certificate, lapel pin, medallion and device to affix to the alumni award.
